REGISTRATION INFORMATION

The Palmetto Cyber Defense Competition is a three-day Cyber Defense Competition that is hosted by the Naval Information Warfare Center (NIWC) Atlantic in collaboration with the South Carolina Lowcountry Chapter of the Armed Forces Communications and Electronics Association. PCDC 2021 consists of a High School level competition on 17 April, collegiate on 18 April and professional on 19 April. The 2021 competition will be completed virtual. Teams may compete from one location or multiple locations.

To register to compete/participate in the 2021 PCDC event, teams must complete and submit the below forms:

- One **Team Registration Form** per team.
- One **Consent and Release Agreement** per participating student.

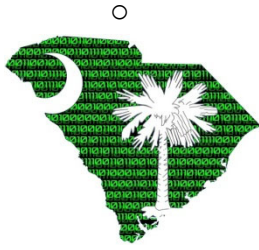
TEAM ELIGIBILITY

Ten (10) teams will be competing at the professional level. The competing teams are a combination of DoD and corporate partner teams. Each team is required to register six team members this year to compete. A seventh team member may act as the team lead, but only six AWS workspaces will be available.

Eligibility for the Professional Competition

- Each team member must be a **current** undergraduate or graduate student attending the college of the team.
- Each team member must be a current employee of the organization.
- Team Composition:
 - Minimum of three (3) **active** team members
 - Maximum of six (6) **active** team members
 - One additional team member may act as team lead
